

The history of the LUKROM parent company dates to 1991. It focused exclusively on trade in agricultural commodities. During its growth, the company has gradually developed into provide comprehensive services into the agricultural public.

## **Economic and Legal Division**

At present, LUKROM Ltd. operates approximately twenty different centres, mainly in Moravia. One of these is in the town of Lipa which is just outside Zlin. It is the largest centre with regards to number of employees. There are four divisions operated from the centre in Lipa. These are the Economic and Legal Division, the Agrochemical Division, the Production of Compound Feed and Agricultural Commodities Division and Livestock Production Services Division.

The economic and legal division ensures the security of economic and legal services, which is not only imperative for LUKROM, but for all other business included in the holding.

The economic department is responsible for the economic agenda of the company as well as all analytical activity.

The legal department provides all necessary support for all divisions of the company.

The marketing sector ensures all advertising and marketing activities at trade fairs and exhibitions, as well as support for individual centres and internal communication.


The administration building in Lipa was acquired in 1994 and has since gone through extensive reconstruction to present a modern appearance both on the exterior and interior.


## Sales Development LUKROM, Ltd.

data for 2018–2022 in millions of EUR




Number of Employees LUKROM, Ltd.


## **Livestock Production Services Division**







# Agricultural Machinery Division







## Primary Production

During its tenure, LUKROM Ltd. has founded or invested capital in several enterprises engaged in crop and livestock production.

On an area of approximately 12.2 thousand hectares, tradi-tional cereals and oilseeds are cultivated and a large part also forms permanent grassland. Most of the cultivated area is in Southern and Central Moravia.


The total number of cows to market milk production is around 1600 pieces. The total number of pigs within the entire group is around 16 thousand units per year. Part of the primary production plants is also chicken

## RACIOLA Uhersky Brod, Ltd.

RACIOLA Inc. is involved in the slaughter and processing of chickens, both light, producing processed poultry products and specialties. Currently, the company has around 110 employees. The annual revenue from its own products amounts to approximately 20 mil. EUR.

The history of the company dates to 1948. After 1968, it became part of the Velkopavlovice poultry farms and factories specialized in the production of hams. It is said that the first Czechoslovakian ham was produced in RACIOLA. In 2004, the company slaughter line underwent a reconstruction, and capacity has since increased from 2,500 to 6,000 pieces of poultry.

Every year, the company processes 5 million pieces of chicken that are only sourced from Czech and Slovak farms. The supply of live chickens is provided by LUKROM Ltd. The process is effectively monitored from the begi-nning until the finished product, including the preparation of compound feed to the feeding and processing the final product.

The slaughterhouse and portioning hall labeled 8022 CZ hold an internationally recognized quality standard certification IFS (International Foods Standard).


RACIOLA offers whole refridgerated and frozen poultry and chickens. The company is well-known for its high quality hams, sausages and other specialities. RACIOLA distributes its products to many supermarket chains, both international and national. Customers can find the complete selection in the plant shops that are based in Uhersky Brod and Veselinad Moravou.



## FC TRINITY Zlin, Inc.

The owner of LUKROM spol. s r.o. Zdenek Cervenka became the owner of FC TRINITY Zlin in 2001 and our company LUKROM became the general partner of the premier league football club FC TRINITY Zlin, Inc. (formerly FC TESCOMA Zlin, Inc.)

The club has a long history. In its modern history, especially after the year 2002, when the cooperation with the LUKROM holding began, Zlin fought their way back to the top league and in 2004 advanced to the 3rd round of the Intertoto Cup. This brought players of the famous Spanish club Atlético Madrid to the Letna stadium and it announced SOLD OUT. The Cobblers, as the team is nicknamed thanks to the shoemaking history of the city of Zlin, maintained their activities in the 1st league until the 2008/2009 season. That season did not work out for the club and it started 6-year long years in the lower leagues. However, the club later returned to bask in the glory in 2015 and since then it has shown that it definitely does not want to go back.

2016/2017 was the most successful year in the century-long history of club. The "A" team won sixth place in the highest Czech competition, the elnsurance league. The team entered this season with great fighting spirit and with the decision to make it to the European competitions. This determination did not go unnoticed, with the team the incredible result of the team being defeated only 3 times after 16 rounds, earning Zlin the nickname "Zlincester" after the English Leicester, who developed from an underestimated "outsider" to a Premier League winner. With this nickname the Zlin footballers appeared, for example, on the websites o2.sport.cz,

expres.cz, sport.cz, isport.cz blesk.cz and fotbal.idnes.cz, among others, and the whole Autumn and they were even noticed by the British Daily Mail Online.

The huge fighting spirit and efforts of the league team culminated in winning the prestigious trophy in the national MOL Cup 2016/17 and winning the Czech-Slovak Super Cup. Thanks to the success in the National Cup, the club was included on the European scene directly in the basic group in the battle for European cups, specifically in the European League. The club traveled around Europe and faced rivals such as FC Lokomotiv Moscow, the Danish FC Copenhagen and the Moldovan Sheriff Tiraspol.
